Proposed acquisition of Inspired by Bidco

This undertaking (the "**Undertaking**") is given by me solely in my capacity as a holder of ordinary shares in Inspired and not in my capacity as a director of Inspired.

1. **OFFER**

In this Undertaking, the "**Offer**" means the offer proposed to be made by or on behalf of Bidco for all of the issued and to be issued ordinary share capital of Inspired, to be implemented by way of a takeover offer under Part 28 of the Companies Act 2006 (the "Act") or, if Bidco so elects, by way of a court-sanctioned scheme of arrangement under Part 26 of the Act (the "Scheme") between Inspired and the holders of its ordinary shares and substantially on the terms set out in the draft press announcement appended hereto at Schedule 2 (subject to the inclusion of any alternative or additional terms and conditions as may be required to comply with the requirements of the Panel on Takeovers and Mergers (the "**Panel**"), any applicable law or regulation, or as agreed between Bidco and Inspired) (the "**Press Announcement**") and includes any new, revised, improved or increased offer by Bidco (or by one of its subsidiaries).

2. **CONDITION OF UNDERTAKING**

The obligations in paragraphs 5, 7 and 11 of this Undertaking are conditional on the Press Announcement being released no later than 10.00 a.m. (London time) on the date that is one business day from the date of this Undertaking (or such later time and/or date as Inspired and Bidco may agree).

3. **OWNERSHIP OF SHARES**

I hereby represent, warrant and undertake to Bidco and Inspired that:

- 3.1 I have the full beneficial interest in (or am otherwise able to control the exercise of all rights attaching to, including voting rights and the ability to procure the transfer of) the number of ordinary shares of 1.25 pence each in the capital of Inspired ("Inspired Shares") specified in Part 1 of Schedule 1 (the "Existing Inspired Shares") and I hold the Existing Inspired Shares free of any encumbrances or third party rights of any kind whatsoever;
- 3.2 I am also holder of (or are otherwise able to control the exercise of all rights attaching to, and the ability to procure the transfer of) the number of warrants, constituted by the warrant instrument dated 8 January 2025, with the right to subscribe for Inspired Shares, as are specified in Part 2 of Schedule 1 (the "Inspired Warrants" and, together with the Existing Inspired Shares, the "Inspired Securities");

- 3.3 I am also the holder of the number of options, awards and other rights (if any) over Inspired Shares as are specified in Part 3 of Schedule 1 (the "**Options**");
- 3.4 the details of the Inspired Securities and Options set out in Schedule 1 are true, complete and accurate in all material respects as at the date of this Undertaking;
- 3.5 save as set out in Schedule 1, I am not interested in any other securities of Inspired and I do not have any rights to subscribe, purchase or otherwise acquire any securities of Inspired; and
- 3.6 I have full power and authority and the right (free from any legal or other restrictions), and will at all times continue to have all relevant power and authority and the right, to enter into this Undertaking, to perform the obligations in this Undertaking in accordance with its terms, to exercise (or, where applicable, take all steps in my power to procure the exercise of) all voting rights attaching to the Existing Inspired Shares and otherwise to take all necessary actions to transfer (i) the Existing Inspired Shares pursuant to the Offer; and (ii) the Inspired Warrants pursuant to a separate offer to be made by Bidco in respect of the Inspired Warrants under Rule 15 of the Code (the "Warrant Offer").

4. **DEALINGS AND UNDERTAKINGS**

- 4.1 Prior to this Undertaking lapsing in accordance with paragraph 10.1, I irrevocably undertake to Bidco and Inspired that (other than in connection with the Offer or the Warrant Offer), I shall (and shall take all steps in my power to procure that the registered holder(s) shall):
 - 4.1.1 subject to paragraph 4.1 and except as pursuant to the Acquisition, not sell, transfer, charge, encumber, create or grant any option or lien over or otherwise dispose of (or permit any such action to occur in respect of) any interest in or otherwise deal in any Inspired Securities or any other shares in Inspired issued or unconditionally allotted to, or otherwise acquired by, me or any shares in the capital of Inspired in respect of which I become the registered holder or beneficial owner ("**Further Inspired Shares**"); or
 - 4.1.2 not vote in favour of any shareholder resolution to approve an acquisition of or any other transaction in relation to Inspired which is proposed by any person other than Bidco or which would, or could reasonably be expected to, otherwise frustrate, impede or delay the Offer or any part thereof; or
 - 4.1.3 not accept, or give any undertaking in each case in my capacity as a shareholder (whether conditional or unconditional) to accept, any offer or transaction, or approve any offer or transaction made or proposed to be implemented by way of a contractual offer, scheme of arrangement or otherwise in respect of securities in Inspired by any person other than Bidco or which would, or could reasonably be expected to, otherwise frustrate, impede or delay the Offer or any part thereof; or
 - 4.1.4 except as a result of any Options being exercised or vesting, until the earlier of (i) this Undertaking lapsing in accordance with paragraph 10, or (ii) the Offer becoming or being declared unconditional, not acquire or otherwise deal or undertake any dealing in any relevant securities of Inspired (or any interest therein) unless the Panel determines and confirms to you that, in respect of such acquisition or dealing, I am not acting in concert with you pursuant to Note 9 to the definition of "Acting in concert" set out in the Code or otherwise; or
 - 4.1.5 not exercise (or, where relevant procure the exercise of) the Inspired Warrants;
 - 4.1.6 to the extent that the Offer is structured as a Scheme, exercise (or, where relevant take all steps in my power to procure the exercise of) all voting rights or otherwise take all

necessary actions in order to approve the implementation of such scheme of arrangement; or

- 4.1.7 other than pursuant to this Undertaking, not enter into any agreement or arrangement, incur any obligation or give any indication of intent (or permit such circumstances to occur):
 - (a) to do all or any of the acts referred to in paragraphs 4.1.1 to 4.1.6 (inclusive) above; or
 - (b) in relation to, or operating by reference to, any Inspired Securities and which would or might restrict or impede my ability to comply with this Undertaking,

and, for the avoidance of doubt, references in this paragraph 4.1.7 to any agreement, arrangement or obligation shall include any such agreement, arrangement or obligation whether or not legally binding or subject to any condition, or which is to take effect following the closing of the Offer or upon the Offer lapsing or being withdrawn or upon, or following, this Undertaking ceasing to be binding or upon, or following, any other event,

provided, for the avoidance of doubt, that the foregoing undertakings in this clause 4.1 will not in any way restrict any actions taken by me in my capacity as a director of Inspired or any of its subsidiaries.

- 4.2 Paragraph 4.1 (if and to the extent applicable) shall not restrict me from selling or disposing of Inspired Shares (or interest in such shares) as part of my bona fide tax planning, and provided always that prior to any such disposal: (a) the intended transferee or beneficiary enters into an undertaking in favour of Bidco in terms no less favourable to Bidco than those set out herein and which does not contain this paragraph 4.2 or any clause similar to it; (b) I notify Bidco no less than five business days before such disposal of those terms in their entirety and (other than in relation to any transfer to my spouse, children or a related family trust) obtain Bidco's consent for the transfer, such consent not to be unreasonably withheld or delayed; and (c) such undertaking includes a term obliging the intended transferee or beneficiary to send to Bidco an executed and dated version of the undertaking (in any form) on the day that it is executed and dated.
- 4.3 I shall accept: (i) the Warrant Offer; and (ii) any proposal made by Bidco to holders of options over Inspired Shares in compliance with Rule 15 of the Code in respect of all such Options held by me not later than seven days after Bidco sends such proposals to the holders of options or otherwise ensure that any Inspired Shares arising on conversion of or exercise of options or vesting of awards prior to the Offer becoming or being declared unconditional participate in the Offer.

5. UNDERTAKING TO ACCEPT THE OFFER

- 5.1 I hereby irrevocably undertake on the terms of this paragraph 5 in respect of the Inspired Securities, the Further Inspired Shares and any other shares or interests in shares attributable to or deriving from such shares (together, the "**Shares**").
- 5.2 I irrevocably undertake to Bidco and Inspired to accept (or to take all steps in my power to procure the acceptance of, as applicable) the Offer, in accordance with its terms in respect of the Shares by not later than 3.00 p.m. on the fifth business day after the date of despatch to Inspired shareholders of the formal document containing the Offer (the "Offer Document") (or, in respect of any Further Inspired Shares acquired by me after the publication of the Offer

Document by the earlier of: (i) five business days of such acquisition; and (ii) the last day on which the Offer may be accepted), by either:

- 5.2.1 in respect of any Shares held in certificated form, returning to Bidco, or taking all steps in my power to procure the return to Bidco, or as Bidco may direct, duly completed and signed form(s) of acceptance relating to the Offer and I also agree to forward, or procure to be forwarded, with such form(s) of acceptance the share certificate(s) or other document(s) of title (or a form of indemnity acceptance to the directors of Inspired in respect of any lost certificate(s)) in respect of the relevant Shares;
- 5.2.2 in respect of any Shares held in uncertificated form, sending (or taking all steps in my power to procure that any CREST sponsor sends) to Euroclear UK & International Limited the relevant Transfer to Escrow instruction accepting the Offer (in accordance with the procedures described in the Offer Document) in respect of the relevant Shares; or
- 5.2.3 in the case of both paragraph 5.2.1 and 5.2.2, taking such other steps as may be set out in the Offer Document to effect the acceptance of the Offer and transfer to Bidco of the Shares.
- 5.3 I irrevocably undertake that I shall, notwithstanding the provisions of the Code on or any terms of the Offer regarding withdrawal, not, before my obligations under this Undertaking lapse in accordance with paragraph 10.1, withdraw such acceptance(s) and I shall, before my obligations under this Undertaking lapse in accordance with paragraph 10.1, take all steps within my power to procure that any acceptance(s) in respect of the Shares are not withdrawn.
- 5.4 I hereby irrevocably undertake that Bidco shall acquire the Shares pursuant to the Offer free of any lien, charge, option, equity or encumbrance of any nature whatsoever and together with all rights of any nature attaching to those Shares.

6. **POWER OF ATTORNEY**

- 6.1 In order to secure the performance of my obligations under this Undertaking, I irrevocably appoint any director of Bidco jointly and severally to be my attorney in my name and on my behalf to sign or execute forms of acceptance or, as the case may be, forms of proxy and/or such other deeds or documents as may be necessary for the acceptance of the Offer or, as the case may be, the implementation of the Scheme (as defined below), and to do such other acts and things as may be necessary for or incidental to the purpose of giving effect to my obligations in this Undertaking in respect of the Shares. However, the appointment shall only take effect if I have failed to comply with any of my obligations under paragraphs 4, 5, 7 or 11 of this Undertaking and then only to the extent necessary to give effect to such obligations.
- 6.2 I acknowledge that this power of attorney is given by way of security and is irrevocable until this Undertaking lapses in accordance with paragraph 10.1.

7. VOTING RIGHTS AND PREJUDICIAL ACTION

- 7.1 I hereby irrevocably undertake to Bidco and Inspired that, before my obligations under this Undertaking lapse in accordance with paragraph 10.1 that:
 - 7.1.1 I shall exercise (or, where applicable, take all steps within my power to procure the exercise of) the voting rights attached to the Shares on any resolution which would assist or impact the implementation of the Offer if it were passed or rejected at a general, class or other meeting of Inspired shareholders only in accordance with Bidco's directions;

- 7.1.2 I shall not requisition, or join in the requisitioning of, any general or class meeting of Inspired for the purposes of voting on any resolution to approve an acquisition of or any other transaction or corporate action in relation to Inspired which is proposed in competition with or which would otherwise be reasonably expected to frustrate, impede or delay the Offer or any part thereof; and
- 7.1.3 I shall not exercise (nor procure the exercise of) the voting rights attached to the Shares for any resolution which might prevent or delay the implementation of the Offer, and shall exercise (or take all steps in my power to procure the exercise of) the voting rights attached to the Shares against any resolution which purports to approve or give effect to a proposal by a person other than Bidco to acquire (or have issued to it) any Inspired Shares or any assets of Inspired,

and in each case, to the extent that I am not the registered holder of any Shares, I shall take all steps in my power to procure that the registered holder(s) of the Shares comply with this paragraph 7 as if the undertakings in this paragraph 7 apply to them directly.

7.2 For the purposes of this paragraph 7, I shall execute (or take all steps in my power to procure the execution of) any form of proxy required by Bidco appointing any person nominated by Bidco to attend and vote at the relevant meeting (or any adjournment thereof) and I shall not revoke or procure the revocation of, or take any action which has the effect of revoking, any such proxy.

8. CONSENTS

8.1 <u>I agree to:</u>

- 8.1.1 promptly inform you of all information in relation to the Shares as you may require in order to comply with the requirements of the Code, the Panel, the court or of other applicable law or regulation and notify you as soon as possible in writing of any material change in the accuracy or import of any such information and consent to the public disclosure of such information;
- 8.1.2 the inclusion of references to me and the registered holder(s) of any of the Shares in which I have (or will have as the case may be) a beneficial interest and to particulars of this Undertaking and my interests in Shares being set out in the Press Announcement;
- 8.1.3 particulars of this Undertaking being set out in any other announcement or document issued in connection with the Offer and in the Offer Document; and
- 8.1.4 this Undertaking being available for inspection during the offer period (and any related competition reference period) in accordance with Rule 26.2 of the Code or the AIM Rules for Companies or its successor from time to time.

9. ANNOUNCING AND PROCEEDING WITH THE OFFER

I acknowledge that the release of the Press Announcement is at Bidco's absolute discretion. For the avoidance of doubt, nothing in this Undertaking shall oblige Bidco to announce or proceed with the Offer or the Scheme (as applicable).

10. LAPSE OF UNDERTAKING

10.1 This Undertaking and all of my obligations pursuant to this Undertaking will lapse and cease to have effect on the earliest of the following occurrences:

- 10.1.1 the Press Announcement is not released by 10.00 a.m. (London time) on the date that is one business day from the date of this Undertaking (or such later time and/or date as Inspired and Bidco may agree);
- 10.1.2 the Offer Document is not sent to shareholders of Inspired within 28 days (or such longer period as the Panel may agree) after the date of the Press Announcement; or
- 10.1.3 Bidco announces, with the consent of the Panel, that it does not intend to make or proceed with the Offer and no new, revised or replacement offer or scheme is announced in accordance with Rule 2.7 of the Code at the same time; or
- 10.1.4 the Offer does not become or is not declared unconditional, is withdrawn or lapses in accordance with its terms and no new, revised or replacement acquisition (to which this undertaking applies) is announced in accordance with Rule 2.7 of the Code at the same time; or
- 10.1.5 the date on which any competing offer for the entire issued and to be issued share capital of Inspired is declared wholly unconditional or, if implemented by way of a scheme of arrangement, becomes effective.
- 10.2 If this Undertaking and my obligations in this Undertaking lapse, I shall have no claim against Bidco or Inspired and neither Bidco nor Inspired shall have any claim against me, in each case other than in respect of any prior breach of any of the terms of this Undertaking.

11. SCHEME OF ARRANGEMENT

- 11.1 I note that Bidco reserves the right, and may elect, to implement the Offer by way of a Scheme. In the event that it is so implemented, I confirm and agree that this Undertaking shall continue to be binding *mutatis mutandis* in respect of the Shares and all references to the Offer shall, where the context permits, be read as references to the Scheme (or to both the Scheme and the Offer, as appropriate). Notwithstanding the generality of the foregoing, references in this Undertaking:
 - 11.1.1 to accepting the Offer (or procuring the same) shall be read and construed as references to voting in favour of the Scheme and voting in favour of the resolutions to be proposed at any general or class meeting of the Inspired shareholders (or taking all steps in my power to procure the same). I further undertake, if so required by Bidco, to execute (or, where applicable, procure the execution of) all such other documents or do (or, where applicable, procure the doing of) such other acts as may be necessary or desirable for the purpose of giving Bidco the full benefit of my undertakings;
 - 11.1.2 to the Offer becoming or being declared unconditional shall be read as references to the Scheme becoming effective; and references to the Offer closing, lapsing or being withdrawn shall be read as references to the Scheme lapsing or being withdrawn; and
 - 11.1.3 to the Offer Document shall be read as references to the Scheme Document.

12. **OTHER**

- 12.1 Any time, date or period referred to in this Undertaking may be extended by mutual agreement between the parties but, as regards any time, date and period originally fixed or as extended, time shall be of the essence.
- 12.2 I agree that damages would not be an adequate remedy for breach of this Undertaking and, accordingly, Bidco shall be entitled to the remedies of specific performance, injunction or other

equitable remedies for any actual or threatened breach of this Undertaking and no proof of special damages shall be necessary for the enforcement by Bidco of its rights under this Undertaking.

- 12.3 The ejusdem generis principle of construction shall not apply to this Undertaking. Any phrase introduced by the terms "other", "including", "include" and "in particular" or any similar expression shall be construed as illustrative and shall not limit the sense of the words following or preceding those terms.
- 12.4 In this Undertaking, references to:
 - 12.4.1 "**Offer**" shall include any new, increased, renewed or revised acquisition proposals made by or on behalf of Bidco;
 - 12.4.2 "Code" means the City Code on Takeovers and Mergers as amended from time to time;
 - 12.4.3 "**business day**", "**dealing**" and "**offer period**" shall be interpreted in accordance with the Code as from time to time amended and interpreted by the Panel;
 - 12.4.4 being "**interested in**" or having "**interests in**" shares or securities shall be construed in accordance with the Code as from time to time amended and interpreted by the Panel and Part 22 of the Act; and
 - 12.4.5 "**relevant securities**" shall be construed in accordance with the Code as from time to time amended and interpreted by the Panel.
- 12.5 No term of this Undertaking is enforceable under the Contracts (Rights of Third Parties) Act 1999 by a person who is not party to it.

13. GOVERNING LAW AND JURISDICTION

This Undertaking and all non-contractual obligations arising from or in connection with this Undertaking are governed by and construed in accordance with English law. I submit to the exclusive jurisdiction of the English courts to settle any dispute arising from or connected with this Undertaking (a "**Dispute**") (including a dispute regarding the existence, validity or termination of this Undertaking or relating to any non-contractual or other obligation arising out of or in connection with this Undertaking or its formation). I agree that the English courts are the most appropriate and convenient courts to settle any Dispute and, accordingly, will not argue to the contrary.
